Is SKYGATE a startup company or has SKYGATE already established itself in the market? The SKYGATE model company has been successfully operating on the market for many years!

Where is the headquarters of SKYGATE and why did SKYGATE choose this location?

Most global crypto projects choose a corporate location in countries with questionable legal security and stability. We consciously chose the economic location of Austria, thus subjecting ourselves to the strict legal regulations of the European Union as well as the strict national regulations of Austria.

Why was an "Advisory Board" installed?

SKYGATE has an extensive management structure composed of professionals with years of experience. The "Advisory Board" serves as an additional supervisory body to monitor management and business leadership, represent the interests of token buyers, and ensure the success of the project.

Has SKYGATE submitted the project to the Austrian Financial Market Authority?

Certainly. Upon completion of the project, the first step was to submit our project to the Austrian Financial Market Authority. This was done to determine what concessions SKYGATE needs and to obtain legal certainty as to whether the SKYGATE token qualifies as a "utility token."

Has SKYGATE examined the requirements of MiCAR, and does SKYGATE meet the requirements of MiCAR?

MiCAR stands for "Markets in Crypto-Assets Regulations." This is the new legislation adopted by the European Union for the crypto market, which must be implemented by member states. MiCAR distinguishes several types of cryptocurrencies:

Asset-referenced Tokens ("ART")

Electronic Money Tokens ("EMT")

Other crypto-assets The SKYGATE token is classified as "other crypto-assets," which is very similar to the definition of a "utility token." SKYGATE has had legal experts examine the requirements for "other crypto-assets" under MiCAR and meets all necessary requirements! Changes in legal regulations are possible, and SKYGATE commits to promptly complying with any legal changes and successfully implementing any additional requirements within legal deadlines!

What does KYC mean, and why is KYC required?

KYC means "Know your client". It is an official requirement that sales of cryptocurrencies above a certain amount must be checked to prevent money laundering. If the purchase price exceeds a certain amount, the buyer must register and show an official photo ID. The current amount from which KYC is required can be found in our "How to buy" section.

The buyer must register and present an official photo ID. In the registration process, one must show the ID in front of the camera of the smartphone/tablet/PC. We collaborate with the renowned company IDnow, which conducts the verification process quickly and easily in just a few minutes. It also complies with high standards of data protection laws.

Does SKYGATE plan to list the token on one or more exchanges?

SKYGATE aims to list on most well-known and reputable crypto exchanges. However, for the benefit of the community (token holders), listing must be carefully planned and the perfect timing chosen. A large "community" and successful project progress are of significant advantage for a successful listing. Therefore, we plan to list only in the final phase of our project! This approach is conducive to a successful price development.

Does Skygate have the necessary license?

Are price developments/increases possible on crypto exchanges?

Certainly. SKYGATE has no influence on price development on a crypto exchange. However, SKYGATE has considered how to support a positive price development.

How does SKYGATE plan to support a positive price development?

The positive price development depends on supply and demand. SKYGATE has developed several project components that can have a very positive impact on supply and demand. Through the "World of SKYGATE," we create a unique digital experience that can be of interest to millions of users worldwide. The SKYGATE token grants access to this digital world and the consumption of various services offered in this world. By constantly reinvesting 50% of the company's profits and thus continually expanding the services offered by SKYGATE, there will constantly be new demand for SKYGATE tokens, thereby increasing demand for the tokens continuously. Through quarterly token burns, we continuously reduce the tokens available on the market, thus reducing the supply of available tokens. This allows us to positively influence supply and demand. The tokens allocated to the team, advisors, and partners are locked for several years and cannot be used or sold, thus also not negatively affecting the price.

What advantage do early adopters who acquire SKYGATE tokens during the pre-sale have?

Early adopters have significant advantages! Token purchase is possible at very low purchase prices, allowing for potential value increases of the investment.
